Appearance

Straw-yellow coloured smooth powder with delicate aroma of cheese and typical flavour with a fresh hint.

Characteristics

Semi finished product in powder with a high content of dehydrated "fresh and creamy" cheese (first ingredient) to be added to the mix base to prepare gelati featuring a fresh and slightly sourish hint. It has been studied to present in ice cream parlour the flavour of the famous American cake made of creamy cheese, popular and widely known all over the world with different names (ex. Käsekuchen). Gelato can be customised by variegating it with raspberry, little strawberries, a.s.o. as well as by filling it with biscuits or crumbled short

Excellent also for plentiful further purposes in cold confectionary.

Fresh CHEESE in powder, malt dextrines, LACTOSE, MILK proteins, flavours, acidifier: citric acid; colours: plain caramel, curcumin. May contain: SOYA, EGGS, ALMONDS, HAZELNUTS, WALNUTS, CASHEW NUTS, PISTACHIOS.

Dose and use instructions

60-70 g per liter of milk base mix. Cheesecake flavoured gelato can be presented white or variegated, for example with Pastefrutta 200 (ex. Raspberry 200) and with the products of the Variegati Quattrostagioni range (ex. Little Strawberries and Confectionary Wild Berries) and filled with Digestive biscuits or alike or with the bakery products of the Fornogel range

Storage

The product, stored in the original sealed container, in a cool and dry place, will keep its original features unchanged for at least 12 months since the production date. The "best before" term is printed on each package.
